A common theme is charities need to demonstrate they are meeting a need effectively with clear outcomes and benefits, good leadership, sensible business plans, and a commitment to excellence.

This course will guide you through the application process, taking into account the priorities of the Foundation. Applicants applying to the Foundation need to be registered charities. CIC's and social enterprises are not eligible for funding.

This session will help you:

- Understand principles and processes to access Garfield Weston funding
- Present your project in line with the Foundation's key priority areas
- Learn about evidencing need and developing your project outcomes and impact
- Explore methods to develop your project budget




None of this is unusual.

It looks at how you can research the funder beyond what you first see on a website and develop relationships that benefit the funder as well as your organisation.

This session also looks at ways you can really show your value and long-term impact to improve your chances of gaining increased support.

Organisations should periodically assess governance arrangements. But what does a governance review actually mean?

Reviews allows you to make sure you have systems in place to meet compliance requirements and to help plan improvement, promoting a positive culture to helps your organisation achieve what it set out to do. A review covers everything from how your trustees carry out their business and manage your paperwork, to how you measure the impact of your work and how/when you report to funders and regulators. Funders are taking an interest in the governance arrangements of those they support, so getting this right makes your organisation a safer pair of hands.

At the end of this session, you will have the tools to carry out a governance review and take the steps to keep your organisation effective and fundable.

This course will introduce you to different types of governance review and help you plan a proper review process. Take you step by step through a typical governance review process; including what to ask yourself and what to look for.

Reaching Communities is arguably the most important CVS grants program operating today. Competition for Lottery funding has never been greater. Learn how to use your time wisely and tailor your submission to make your bid stand out from the crowd.

This training is delivered bye LCVS funding advisor Ged Simpson who has secured millions of pounds from this fund over the years. Ged will take you through the steps required to plan and prepare a strong submission, considering updates in process and changes in focus or criteria. If you're new to development and bid writing, we recommend that you attend our Introduction to Fundraising training first.

Please note all our funder-specific workshops have been designed using our in-house experience of working with applicants to prepare and submit successful bids.

Henry Smith Funding Workshop

Since 1628, the charity has worked to combat disadvantages and meet the challenges and opportunities facing people throughout the country. One of the largest independent grant-makers in the UK, Henry Smith distributes £30m to good causes each year. This course will take you through the application process, focusing on the Charity's two flagship funding programmes:

Improving Lives, offering grants of £20,000-£60,000 p/a over of 3 years, covering project and running costs for small and medium-sized organisations in the UK (with an annual income between £50,000 - £2m or in exceptional circumstances up to £5m).

Strengthening Communities: grants of £20,000-£60,000 p/a up to 3 years, covering project and running costs for smaller organisations (annual income between £20,000 - £500,000) and are both physically based and working within or immediately next to an area within the 10% most deprived areas in England or Scotland. This course is aimed at anyone who has already been involved in writing applications to small/medium charitable trusts but is now looking to develop project or revenue bids focused under the Charity's key priority areas.

This course will help you:

- Understand the grant programmes
- Be clear about the staged application process for Henry Smith grants
- Understand how to design and develop project ideas, and tackle the application to make the best case for your project
- Evidence need, develop outcomes and develop your project budget

 Explore techniques for writing highquality applications, focused on the two flagship funds available.

Awards For All funding workshop

- support people, communities and organisations facing increased demands and challenges as a direct result of the cost-of-living crisis.

This course is for a wide range of notfor-profit organisations seeking funding to deliver new or existing activity or to support your organisation to change and adapt to new and future challenges.

- Give you an overview of the aims of the Awards for All programme
- Look at each aim in detail
- Introduce you to the application form and give you guidance on how to answer each question
- Explore ways to ensure your project meets local need and is "people-led"
- Run through organisation requirements such bank details, trustees etc

It will teach you what to look for, where, and how to ensure the people you recruit are the people you need. It will also help you support new trustees well, from day one. Esmee Fairbairn Foundation

A journey through the six steps in applying successfully

This session is for established organisations with an annual income in excess of £50,000 who wish to understand more about the Esmee Fairbairn Foundation's areas of support and develop funding applications that stand out from the crowd.

In 2017, the Esmee Fairbairn Foundation allocated £40.5 million in funding to a wide range of projects via grants, alongside a £45 million allocation to social investments. The foundation supports organisations whose work is focused on the arts, children and young people, the environment, food or social change.

When applying for the fund, you will need to be able to demonstrate an annual income in excess of £50,000; the foundation makes very few awards to start-ups. Therefore, this training is less applicable to smaller organisations. Join our funding advisor to learn how to put your best foot forward when applying to Esmee Fairbairn.

If you're considering developing an application to an Esmee Fairbairn Foundation programme, this training is for you. If you are new to project development or bid writing, you should attend our Introduction to Fundraising training first

By the end of this session, you will:

- Understand key criteria for Esmee Fairbairn programmes and have top tips for developing your ideas
- Understand methods for developing and presenting your project, considering priority areas for the different programmes
- Understand how to evidence need and develop outcomes and impact

- Understand techniques for writing high-quality funding applications

An examination of the role of trustees, to equip delegates with knowledge of the legal duties trustees have and how boards arrange their work. Trustees and directors are ultimately accountable for an organisation. Everything runs through them, strategy, planning, and fundraising.

A well-run board sets the agenda and ensures an organisation is on-track, supporting staff and volunteers. A poorly running board can lead to paralysis, with staff not supported, finances not managed and the organisation being non-compliant.

This can all lead to high staff turnover, service users leaving, financial problems and possible closure. This course is perfect for trustees, directors, committee members and the staff that work with them. Support your trustees with tools and techniques to help them work together, oversee projects and keep the organisation on track.

Heritage Lottery Funding Workshop

In 2019, Heritage Lottery Fund introduced an accessible process to its grant-making. This training looks at the process and provides top tips for securing a grant towards heritage-focused projects.

Heritage projects include many different things from the past that we value and want to pass on. It can include historic sites, buildings, artefacts of cultural traditions and oral history.

Since 1994 the Heritage Lottery Fund has used money raised by the National Lottery to help people across the UK explore, enjoy and protect the heritage they care about.

HLF is the largest dedicated funder of heritage in the UK and a leading advocate for its value. It has awarded $\pounds 7.7$ billion to over 42,000 projects since 1994. Funding of between $\pounds 3,000$ and up to $\pounds 5,000,000$ is available through a range of focused schemes.

Corporate Fundraising

Even the smallest of charities can benefit from fundraising in the private sector. Whatever the size of the organisation you're fundraising for, it is imperative that you take the right approach.

You'll learn how and where to invest resources and what makes your organisation a desirable 'business partner'.

Learn to confidently demonstrate your organisation's value to the private sector and form relationships with new potential funders.

This session will enable you to plan and manage projects so that results are delivered on schedule and to specification. It will help you structure a work plan for both one-off projects and ongoing work. The session is designed for the not-for-profit sector and is adaptable to any project – short or long-term, simple or complex. 
